Technical Skills. Ability to read and interpret simple blueprints. Ability to add, subtract, multiply and divide numbers. Ability to perform mathematical skills in the form of measurement and other work material calculations utilizing a calculator. Ability to use hoists and various hand and power tools (band/circular saws, scales, foam generating and banding equipment) with precision and dexterity. Ability to complete NYS Hazmat DOT training. Ability to obtain and maintain forklift certification.

- 3. Accurately document and perform computerized transactions related to receiving, inspecting, storing, transporting and issuing materials.
- 4. Precisely follow written & verbal instruction to pick parts, kit materials, and transport goods throughout the facility.
- 5. As directed, conduct accurate cycle counts and properly document inventory levels. Escalate issues or discrepancies to supervision.
- 6. Provide support to shipping department with packaging and pallet building.
- 7. Continuously maintain a safe, clean, and organized work area. Ensure tools and other items are safely and properly stored.
- 8. Regularly perform housekeeping tasks.
- 9. Promote positive Team Member and customer relations by supporting Pyrotek's commitment to a working environment of tolerance, acceptance and civility. Respond appropriately to inquiries, concerns and complaints by being professional, courteous and respectful at all times.
- 10. Maintain regular, consistent, reliable, punctual and predictable attendance, as required to achieve internal and external customer satisfaction.
