### JOB SUMMARY

Assist with the inventory management and distribution of products by loading/unloading shipments, pulling orders from inventory, delivering production materials and supplies, and staging finished product.

### QUALIFICATIONS

#### Education/Experience

High School diploma or General Education Development (GED) / Test Assessing Secondary Completion (TASC), plus one (1) year in a manufacturing, warehouse, or shipping environment preferred, or equivalent combination of education and experiences.

Technical Skills. Ability to safely and effectively use a variety of hand and power tools (steel cutters, crowbar, claw hammer) with precision and dexterity. Ability to perform mathematical skills in the form of measurement and other work material calculations utilizing a calculator. Ability to obtain and maintain forklift certification.

2. Load and unload deliveries using hand trucks, pallet jacks, and forklifts.
3. Precisely count, weigh and/or measure incoming or outgoing items in a timely manner; compare identifying information to bills of lading, invoices, orders, or other records to ensure accuracy.
4. Thoroughly examine incoming shipments for damages and/or discrepancies and notify supervisor in a timely manner to rectify issues, as needed.
5. Assist in reviewing pick sheets based on customer orders/production demand and pull the correct product(s) for each order.
6. Accurately perform part kitting and delivery of kits to production lines.
7. Continuously maintain a safe, clean and organized working environment.
8. Promote positive Team Member and customer relations by supporting Pyrotek's commitment to a working environment of tolerance, acceptance and civility. Respond appropriately to inquiries, concerns and complaints by being professional, courteous and respectful at all times.
9. Maintain regular, consistent, reliable, punctual and predictable attendance, as required to achieve internal and external customer satisfaction.
10. Actively and positively participate in problem resolution, demonstrating constructive communication, timely response and effective resolution skills. Work effectively within team environments both within your department and across the organization.
11. Cooperate and comply fully with all Pyrotek policies and procedures. Actively support and follow the Pyrotek Safety Program.
