2. Overview of Epworth HealthCare

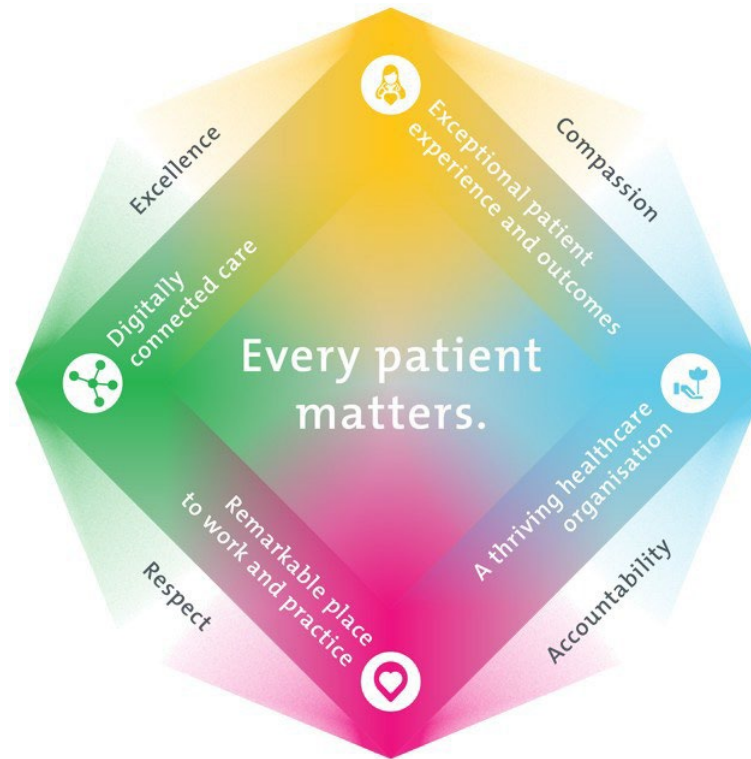
