# **General Accountability:**

# Purpose and Scope

Taking direction from the Police Services Supervisor and reporting to the Police Services Supervisor and RCMP Municipal Manager, the Forensic Video Technician will perform specialized technical work utilizing forensic video techniques in support of the Police Services department and the Asset Management department clients. The incumbent will review videos with a technical lens and process a variety of video evidence for investigative and court purposes. The incumbent will also provide administrative support, such as answering inquiries, word processing, and preparing and maintaining various documents and files, to the staff in the Forensic Identification Section.

# Nature and Scope of Work

Performs a wide variety of specialized technical work and clerical duties including, but not limited to, the following functions:

- Provides clients with technical forensic video services, including request triage, still image capture from video, enhancement of video/still imagery, conversion of video, acquisition of digital multimedia evidence (DME), narrative editing of video evidence and concealment of video.
- Reviews and performs technical level processes on a variety of video evidence for investigative or court purposes and witness testimony in court.
- Provides general advice to clients on video evidence, including acquisition and handling best practices and admissibility requirements.
- Writes technical level reports.
- Prepares and maintains all files and documentation prescribed by departmental policies.
- Safeguards all materials and ensures all documents relating to case are recorded and properly organized.
- Maintains database and video library of all material according to prescribed policies and procedures.
- Utilizes RCMP database applications (including, but not limited to PRIME and CPIC) to browse and query data, enter data, assign files as necessary for processing or follow up, and/or research and prepare correspondence to external agencies.
- Updates and maintains department reference material.
- Maintains reference manual for position duties for backup personnel.
- Performs other related duties as assigned.

# **Necessary Qualifications**

# Technical Knowledge/Skills:

- Understands and appropriately applies principles, techniques, procedures, requirements, regulations, and policies related to the field of forensic video and access to information pursuant to respective privacy legislation and security policies.
- Employment standards including Work Safe regulations.
- Computer efficiencies including proficiency in Microsoft Word (intermediate level) proficiency in Microsoft Excel (basic level) and intermediate proficiency and considerable knowledge in video editing and related applications.
- Must pass and maintain RCMP Secret Security Screening.

# Education/Training/Certification:

- Must possess and maintain a valid Class 5 driver's licence, and produce and maintain a clean driver's abstract, as per City policy.

# Experience:

• Minimum three (3) years related experience in video technology role, preferably in law enforcement environment, within the last five (5) years.

# **Unusual Working Conditions:**

- Must achieve and maintain RCMP Reliability Security Screening.
- Exposure to video/still imagery of a sensitive, graphic, and disturbing nature while carrying out duties, sometimes for prolonged periods of time.
- May be required to acquire off-site video evidence for investigative files.

# Preferred Criteria (External Hires):

• Completion of certification program for Forensic Video Technicians.
