Overview and Objectives of the position:

About the Role

It encompasses oversight of team performance, workload coordination, and delivery of high-quality financial services to internal stakeholders.

The successful candidate will play a key leadership role, offering expertise in the interpretation and application of accounting standards and ensuring compliance with regulatory requirements. The role will also drive continuous process improvement initiatives, enhance operational efficiency, and support the integration of financial processes for new business units as they are established.

Key Responsibilities:

Strategic Management

- Provide strong and effective leadership within the Finance team, fostering a culture of accountability, collaboration, and continuous improvement.
- Maintain up-to-date knowledge of relevant industry regulations and accounting standards, proactively
 assessing their impact on finance operations and recommending appropriate changes to ensure
 ongoing compliance.
- Support the professional growth and development of team members by offering clear guidance, constructive feedback, and access to learning opportunities to build a high-performing and engaged finance team.
- Build and maintain strong, service-oriented relationships with internal stakeholders, ensuring financial services meet business needs and contribute to informed decision-making.
- Lead the implementation of initiatives that enhance business performance, improve financial processes, and optimize resource allocation to deliver efficient and high-impact outcomes.
- Promote cross-functional collaboration by sharing best practices, identifying opportunities for operational efficiencies, and supporting integrated planning efforts across the broader Navitas business.

Finance Management

- Manage two Senior Financial Accountants and their respective teams, including setting performance objectives, mentoring, and supporting professional development.
- Oversee all aspects of month-end closing, ensuring accurate revenue and expense recognition, overhead allocations, and timely completion of balance sheet reconciliations - with prompt resolution of outstanding items where applicable.
- Ensure compliance with statutory and regulatory requirements (BAS, IAS, FBT, Income Tax, Transfer Pricing), and with Navitas Group policies and procedures.



- Oversee the accurate integration of data from related systems into the General Ledger and the accounting of commissions, amortisation, accruals, royalties, and management fees.
- Drive operational efficiency and continuous improvement across finance processes, embedding best practices and supporting strategic business outcomes.
- Provide financial leadership and oversight on projects as required, offering guidance and follow-through on key deliverables.
- Liaise with external stakeholders such as auditors, banks, insurance brokers, and legal advisors to support audit readiness and business continuity.
- Maintain compliance with privacy regulations, ensuring secure storage and handling of personal and financial data.
- Partner with Corporate and Divisional Finance teams to foster a data-driven reporting culture, supporting the development and utilisation of the Navitas data warehouse for performance insights.
- Ensure compliance with group-wide policies and procedures and provide necessary training and supervision to uphold workplace health and safety standards.
- Perform other duties as required in support of the finance function and broader business objectives.
- Contribute to cross-functional projects and perform other duties as required, in alignment with the responsibilities of the role.

- CA or CPA qualified (or equivalent professional designation).
- Minimum of 5 years' post-qualification experience in a senior finance role, including proven experience in managing a team.

- Proven experience working independently and leading teams to deliver high-quality outcomes.
- Demonstrated ability to manage multiple priorities, meet tight deadlines, and maintain accuracy under pressure.
- Strong project coordination skills with a keen eye for detail and a commitment to continuous improvement.
- High level of proficiency in Microsoft Office applications, particularly Excel.
- Excellent communication, interpersonal, and self-management skills, with the ability to build strong relationships across teams.
- Demonstrated change management capability, with resilience and adaptability during periods of transition
